### Definition

A message which provides potential buyers with the ability to solicit price, delivery schedule, and other conditions from potential sellers of goods or services.

### Principles

The following general principles apply to the EANCOM® Request for Quote message:

- A potential buyer may solicit offers for one or more goods items or services.
- A request for quote may refer to goods items or services related to one or more delivery schedules, call-offs, etc.
- A request for quote for cross border transactions may contain additional information for customs and/or statistical purposes.

## 4. Segments Description

---

- UNA - C 1 - Service string advice  
The service string advice shall begin with the upper case characters UNA immediately followed by six characters in the order shown below. The same character shall not be used in more than one position of the UNA.
- UNB - M 1 - Interchange header  
This segment is used to envelope the interchange, as well as to identify both, the party to whom the interchange is sent and the party who has sent the interchange. The principle of the UNB segment is the same as a physical envelope which covers one or more letters or documents, and which details, both the address where delivery is to take place and the address from where the envelope has come.

### Request For Quote Heading Section

- UNH - M 1 - Message header  
This message is used to head, identify and specify a message.
- BGM - M 1 - Beginning of message  
This segment is used to indicate the type and function of a message and to transmit the identifying number.
- DTM - M 35 - Date/time/period  
This segment is used to specify the date of the request for quote.
- FTX - C 99 - Free text  
This segment is used to provide any free text information related to the complete request for quote.
- SG1** - C 9999 - **RFF-DTM**  
A group of segments for giving references and where necessary, their dates, relating to the whole message, e.g. contract number, import/export license number, reservation number.
- RFF - M 1 - Reference  
This segment is used to provide or request references which relate to the complete request for quotes message, for example, contract numbers, price list numbers, etc. The references given at this point are valid for the whole document unless superseded by references at line level when the same qualifier is used.
- DTM - C 5 - Date/time/period  
This segment is used to specify dates relating to the references given in the previous RFF segment.
- SG4** - C 5 - **CUX-DTM**  
A group of segments specifying the currencies and related dates/times/period valid for the whole request for quotation.
- CUX - M 1 - Currencies  
This segment is used to specify the currency information relevant to the complete request for quote message.
- DTM - C 5 - Date/time/period  
This segment is used to specify dates related to the rate of exchange.
- SG5** - C 10 - **PAT-DTM**  
A group of segments specifying the terms of payment applicable for the whole order.
- PAT - M 1 - Payment terms basis  
This segment is used to request information regarding the payment terms which apply to the complete Request for Quote.
- DTM - C 5 - Date/time/period  
This segment is used to specify any dates associated with the payment terms.

<b>SG6</b> - C 10	- <b>TOD-LOC</b> A group of segments indicating the terms of delivery for the whole order.
TOD - M 1	- Terms of delivery or transport This segment is used to request information regarding the terms of delivery for the Request for Quote.
LOC - C 2	- Place/location identification This segment is used to specify the location to which the terms of delivery apply.
<b>SG11</b> - C 99	- <b>NAD-SG12-SG14</b> A group of segments identifying the parties with associated information.
NAD - M 1	- Name and address This segment is used to identify the trading partners involved in the Request for Quote process. Identification of the buyer and supplier of goods and services is mandatory in the Request for Quote using DE's 3035 and C082. Additionally, the delivery party may be specified if different from the buyer.
<b>SG12</b> - C 99	- <b>RFF</b> A group of segments giving references only relevant to the specified party rather than the whole message.
RFF - M 1	- Reference This segment is used to specify references related to the party identified in the previous NAD segment.
<b>SG14</b> - C 5	- <b>CTA-COM</b> A group of segments giving contact details of the specific person or department within the party identified in the NAD segment.
CTA - M 1	- Contact information This segment is used to identify the contact department and/or person within the party specified in the NAD segment.
COM - C 5	- Communication contact This segment identifies the communications number, and type of communications, for the person or department identified in the previous CTA segment.
<b>SG15</b> - C 10	- <b>TDT</b> A group of segments identifying the mode and means of transport relating to the whole order.
TDT - M 1	- Details of transport This segment is used to request information on the means of transport which will be used to deliver the products for the entire message.

There must be at least one occurrence of Segment group 27 within an request for quote. This Segment group may be repeated to give subtitle details.
LIN - M 1	- Line item This segment is used to identify the line item for which a request for quote is being made.
PIA - C 25	- Additional product id This segment is used to specify additional or substitutional item identification codes such as a buyer's or seller's item number.

IMD - C 99	- Item description This segment is used to describe the current line item.
MEA - C 5	- Measurements This segment is used to indicate measurements or limitations of the current line item.
QTY - C 99	- Quantity This segment is used to indicate quantities related to the current line item.
ALI - C 5	- Additional information This segment is used to indicate special conditions or the country of origin of the current line item.
DTM - C 35	- Date/time/period This segment is used to request information on dates relating to the current line item such as availability dates, manufacturing dates, or lead times.
FTX - C 99	- Free text This segment is used to provide any free text information related to the current line item.
<b>SG29</b> - C 100	- <b>MOA</b> A group of segments to allow request of cost breakdown information such as tooling cost, material or overhead cost.
MOA - M 1	- Monetary amount This segment is used to indicate net amounts for the line item for which a quote is requested.
<b>SG31</b> - C 99	- <b>PRI</b> A group of segments identifying the relevant pricing information for the goods or services ordered.
PRI - M 1	- Price details This segment is used to specify pricing information relevant to the current line item.
<b>SG32</b> - C 9999	- <b>RFF-DTM</b> A group of segments giving references and where necessary, their dates, relating to the line item.
RFF - M 1	- Reference This segment is used to provide or request references which are applicable to the current line item only.
DTM - C 5	- Date/time/period This segment is used to request information on dates and times associated with the previous RFF segment.
<b>SG33</b> - C 999	- <b>LOC-QTY-DTM</b> A group of segments specifying destination and quantity details for consignments involving multidestination deliveries.
LOC - M 1	- Place/location identification This segment is used to identify the location of delivery for a split delivery order.
QTY - C 1	- Quantity This segment is used to indicate the delivery quantity for the delivery location specified in the previous LOC segment. The total of all quantities specified in segment group 33 for the line, must equal the value for the total quantity detailed in the QTY segment at line level.
DTM - C 5	- Date/time/period This segment is used to indicate the date, time or period on which the split delivery will take place to the location identified in the LOC segment.

SG34 - C 10	- <b>TAX</b> A group of segments specifying tax related information.
TAX - M 1	- Duty/tax/fee details This segment is used to request information on the type and rate of tax that is applicable for the current line item.
SG39 - C 99	- <b>PAC</b> A group of segments identifying the packaging for goods referenced in the line item.
PAC - M 1	- Package This segment is used to request information on the type of packaging being used for the current line item.
SG46 - C 99	- <b>ALC-SG47-SG48-SG49-SG50-SG51</b> A group of segments specifying allowances and charges for the line items.
ALC - M 1	- Allowance or charge This segment is used to request information on allowances or charges which are applicable to the current line item.
SG47 - C 1	- <b>QTY-RNG</b> A group of segments specifying the quantity of the allowance or charge with its measure unit specifier. A range to which the allowance or charge applies may be specified e.g. An allowance of a free quantity of 20 pieces may be specified if the goods quantity is greater than 1000 pieces.
QTY - M 1	- Quantity This segment is used to specify quantity allowances or charges information for the current line item.
RNG - C 1	- Range details This segment is used to indicate ranges which must be satisfied before which the quantity allowance or charge becomes effective.
SG48 - C 1	- <b>PCD-RNG</b> A group of segments specifying the percentage for the allowance or charge, e.g. The allowance/charge amount is calculated as 5% of the goods value or a price reduction of 5% may be specified if the goods quantity is within the range 5 tons to 10 tons.
PCD - M 1	- Percentage details This segment is used to specify percentage allowances or charges information for the current line item.
RNG - C 1	- Range details This segment is used to indicate ranges which must be satisfied before which the percentage allowance or charge becomes effective.
SG49 - C 2	- <b>MOA-RNG</b> A group of segments specifying a monetary amount for an allowance or charge. A range to which the allowance or charge applies can be specified, e.g. an allowance of EUR 5000 may be specified if goods value is greater than EUR 100000.
MOA - M 1	- Monetary amount This segment is used to specify monetary value allowances or charges information for the current line item.
RNG - C 1	- Range details This segment is used to indicate ranges which must be satisfied before which the monetary allowance or charge becomes effective.
SG50 - C 1	- <b>RTE-RNG</b> A group of segments specifying the rate per unit and basis to which the allowance or charge applies, e.g. The allowance/charge amount is EUR 3 per 10 tons.

RTE - M 1	- Rate details This segment is used to specify rate allowances or charges for the line item being quoted.
RNG - C 1	- Range details This segment is used to indicate ranges which must be satisfied before which the rate allowance or charge becomes effective.
<b>SG51 - C 5</b>	- <b>TAX-MOA</b> A group of segments specifying tax related information for the allowance or charge.
TAX - M 1	- Duty/tax/fee details This segment is used to indicate any taxes which may be applicable against the allowances and/or charges information specified in the ALC segment group.
MOA - C 1	- Monetary amount This segment is used to specify in monetary terms the amount of tax due for the allowances or charges for the current line item.
<b>SG52 - C 10</b>	- <b>TDT</b> A group of segments identifying the mode and means of transport, relating to the line item, where this is different to or not specified within the heading section.
TDT - M 1	- Details of transport This segment is used to request information on the means of transport which will be used to deliver the current line item.
<b>SG54 - C 100</b>	- <b>SCC-SG55</b> A group of segments specifying requested delivery schedules relating to quantities, frequencies, and dates, required for the line item, where this is different to or not specified within the heading section.
SCC - M 1	- Scheduling conditions This segment is used to request information on delivery schedules for the current line item.
<b>SG55 - C 10</b>	- <b>QTY-DTM</b> A group of segments to specify the scheduled quantities, date/time details of the schedule and where required the reference of the schedule.
QTY - M 1	- Quantity This segment is used to request information on quantities for the current delivery schedule.
DTM - C 5	- Date/time/period This segment is used to indicate dates related to the quantities in the delivery schedule.

UNS - M 1	- Section control This segment is used to separate the detail and summary sections of the request for quote message.
MOA - C 15	- Monetary amount This segment is used to indicate total monetary amounts applicable to the complete request for quote, e.g. total value allowance and charges, total taxable amount, etc.
CNT - C 10	- Control total This segment is used to provide message control totals.
UNT - M 1	- Message trailer This segment is a mandatory UN/EDIFACT segment. It must always be the last segment in the message.

UNZ - M 1 - Interchange trailer  
This segment is used to provide the trailer of an interchange.

## 5. Segments Layout

---

This section describes each segment used in the EANCOM® Request for quote message. The original EDIFACT segment layout is listed. The appropriate comments relevant to the EANCOM® subset are indicated.

### Notes:

1. The segments are presented in the sequence in which they appear in the message. The segment or segment group tag is followed by the (M)andatory / (C)onditional indicator, the maximum number of occurrences and the segment description.
2. Reading from left to right, in column one, the data element tags and descriptions are shown, followed by in the second column the EDIFACT status (M or C), the field format, and the picture of the data elements. These first pieces of information constitute the original EDIFACT segment layout.

Following the EDIFACT information, EANCOM® specific information is provided in the third, fourth, and fifth columns. In the third column a status indicator for the use of (C)onditional EDIFACT data elements (see 2.1 through 2.3 below), in the fourth column the restricted indicator (see point 3 on the following page), and in the fifth column notes and code values used for specific data elements in the message.

- 2.1 (M)andatory data elements in EDIFACT segments retain their status in EANCOM®.
- 2.2 Additionally, there are five types of status for data elements with a (C)onditional EDIFACT status, whether for simple, component or composite data elements. These are listed below and can be identified when relevant by the following abbreviations:

- REQUIRED	<b>R</b>	Indicates that the entity is required and must be sent.
- ADVISED	<b>A</b>	Indicates that the entity is advised or recommended.
- DEPENDENT	<b>D</b>	Indicates that the entity must be sent in certain conditions, as defined by the relevant explanatory note.
- OPTIONAL	<b>O</b>	Indicates that the entity is optional and may be sent at the discretion of the user.
- NOT USED	<b>N</b>	Indicates that the entity is not used and should be omitted.

- 2.3 If a composite is flagged as **N, NOT USED**, all data elements within that composite will have blank status indicators assigned to them.
3. Status indicators detailed in the fourth column which directly relate to the code values detailed in the fifth **column** may have two values:

- RESTRICTED	*	A data element marked with an asterisk (*) in the fourth column indicates that the listed codes in column five are the only codes available for use with this data element, in this segment, in this message.
- OPEN		All data elements where coded representation of data is possible and a restricted set of code values is not indicated are open (no asterisk in fourth column). The available codes are listed in the EANCOM® Data Elements and Code Sets Directory. Code values may be given as examples or there may be a note on the format or type of code to be used.

4. Different colours are used for the code values in the segment details: restricted codes are in red and open codes in blue.

Segment Notes:

The service string advice shall begin with the upper case characters UNA immediately followed by six characters in the order shown below. The same character shall not be used in more than one position of the UNA.

This segment is used to inform the receiver of the interchange that a set of service string characters which are different to the default characters are being used.

When using the default set of service characters, the UNA segment need not be sent. If it is sent, it must immediately precede the UNB segment and contain the four service string characters (positions UNA1, UNA2, UNA4 and UNA6) selected by the interchange sender.

Regardless of whether or not all of the service string characters are being changed every data element within this segment must be filled, (i.e., if some default values are being used with user defined ones, both the default and user defined values must be specified).

When expressing the service string characters in the UNA segment, it is not necessary to include any element separators.

The use of the UNA segment is required when using a character set other than level A.

## 5. Segments Layout

---

Segment number: 2

S001: The character encoding specified in basic code table of ISO/IEC 646 (7-bit coded character set for information interchange) shall be used for the interchange service string advice (if used) and up to and including the composite data element S001 'Syntax identifier' in the interchange header. The character repertoire used for the characters in an interchange shall be identified from the code value of data element 0001 in S001 'Syntax identifier' in the interchange header. The character repertoire identified does not apply to objects and/or encrypted data.

The default encoding technique for a particular repertoire shall be the encoding technique defined by its associated character set specification.

DE 0001: The recommended (default) character set for use in EANCOM® for international exchanges is character set A (UNOA). Should users wish to use character sets other than A, an agreement on which set to use should be reached on a bilateral basis before communications begin.

DE 0004, 0008, 0010, 0014, 0042 and 0046: Within EANCOM® the use of the Global Location Number (GLN) is recommended for the identification of the interchange sender and recipient.

DE 0008: Identification (e.g. a division) specified by the sender of the interchange, to be included if agreed, by the recipient in response interchanges, to facilitate internal routing.

DE 0042: Sub-level of sender internal identification, when further sub-level identification is required.

DE 0014: The address for routing, provided beforehand by the interchange recipient, is used by the interchange sender to inform the recipient of the internal address, within the latter's systems, to which the interchange should be routed. It is recommended that the GLN be used for this purpose.

DE 0007: Identification (e.g. a division) specified by the recipient of the interchange, to be included if agreed, by the sender in response interchanges, to facilitate internal routing.

DE 0046: Sub-level of recipient internal identification, when further sub-level identification is required.

DE S004: The date and time specified in this composite should be the date and time at which the interchange sender prepared the interchange. This date and time may not necessarily be the same as the date and time of contained messages.

DE 0020: The interchange control reference number is generated by the interchange sender and is used to identify uniquely each interchange. Should the interchange sender wish to re-use interchange control reference numbers, it is recommended that each number be preserved for at least a period of three months before being re-used. In order to guarantee uniqueness, the interchange control reference number should always be linked to the interchange sender's identification (DE 0004).

DE S005: The use of passwords must first be agreed bilaterally by the parties exchanging the interchange.

DE 0026: This data element is used to identify the application, on the interchange recipient's system, to which the interchange is directed. This data element may only be used if the interchange contains only one type of message, (e.g. only invoices). The reference used in this data element is assigned by the interchange sender.

DE 0031: This data element is used to indicate whether an acknowledgement to the interchange is required. The EANCOM® APERAK or CONTRL message should be used to provide acknowledgement of interchange receipt. In addition, the EANCOM® CONTRL message may be used to indicate when an interchange has been rejected due to syntax errors.

DE 0032: This data element is used to identify any underlying agreements which control the exchange of data. Within EANCOM®, the identity of such agreements must start with the letters 'EANCOM', the remaining characters within the data element being filled according to bilateral agreements.

The following is an example of a simple Request for Quote message for one line item between a supplier identified with GLN 401234500009 and a buyer identified with GLN 541234500013. The buyer identifies the contact who will handle any queries regarding the request as being N Schulte.

The quotation is dated the 1st January 2002 with a reference number RQT709. The buyer requests information on the terms of delivery and the basic payment terms.

The product is identified by GTIN 4012345111118. The buyer requests information on the products dimensions, its calculation gross price for 50 units of the product, its rate of tax, and any allowances available for it. Information is also requested on the main carriage transport which will be used to deliver the product.
