The following notable changes were made to support the May 2023 Publication.

### **Work Request 22-000305 – New Cannabis Bricks**

---

- This work request was elaborated to create new Cannabis bricks under the Class Cannabis Edibles and Cannabis Non-Edibles.
- Total of 10 new Bricks created, 1 Brick removed and 3 Bricks updated.

### **Work Request 22-000392 – Edible Insects**

---

- This work request was elaborated to reflect current business needs. Edible Insects are now available in certain markets and the GPC structure was updated to reflect these changes.
- New Family created (Insects Edible), 2 Classes created (Insects Edible - Prepared/Processed and Insects Edible - Unprepared/Unprocessed) and 20 new Bricks added.

### **Work Request 23-000028 – Industrial Fluid Pumps/Systems**

- This Work request was submitted to have a more intuitive Schema based on what are the products and not their intended use.
- The changes in the GPC structure will allow the Industrial Pumps sector users to easily assign the correct GPC.
