---

- GS1 operates under the GS1 anti-trust caution. Strict compliance with anti-trust laws is and always has been the policy of GS1.
- The best way to avoid problems is to remember that the purpose of the group is to enhance the ability of all industry members to compete more efficiently.
- This means:
  - **There shall be no discussion of prices, allocation of customers, or products, boycotts, refusals to deal, or market share.**
  - If any participant believes the group is drifting toward impermissible discussion, the topic shall be tabled until the opinion of counsel can be obtained.

- The intellectual property rights can either be in development or owned by persons, companies or third parties within this work group or outside this work group.
- We do this under the guidance of the GS1 Intellectual Property Policy, so that GS1 can seek to avoid the uncertainty regarding intellectual property claims against the Specification.

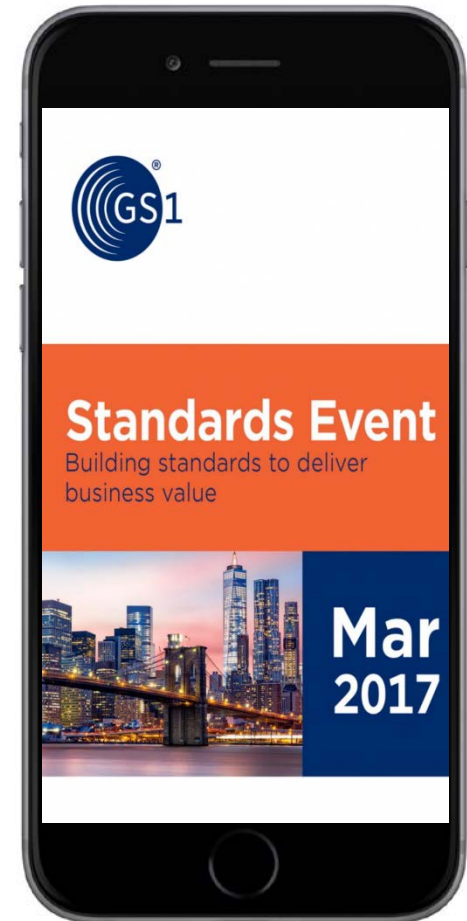

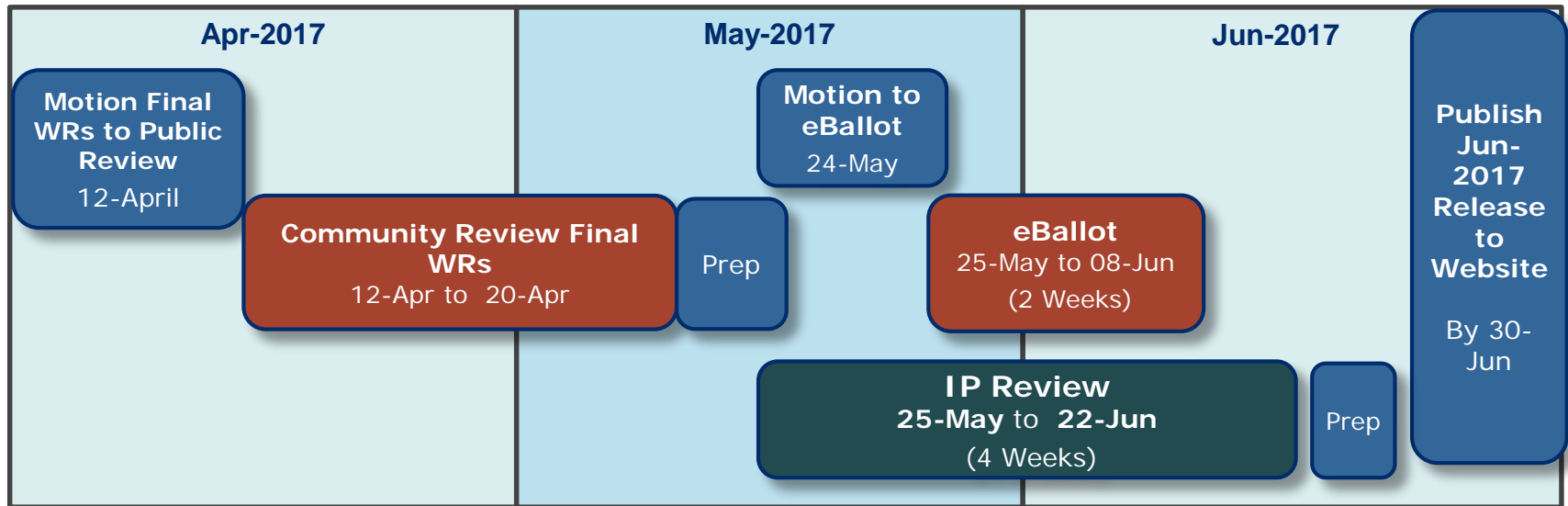

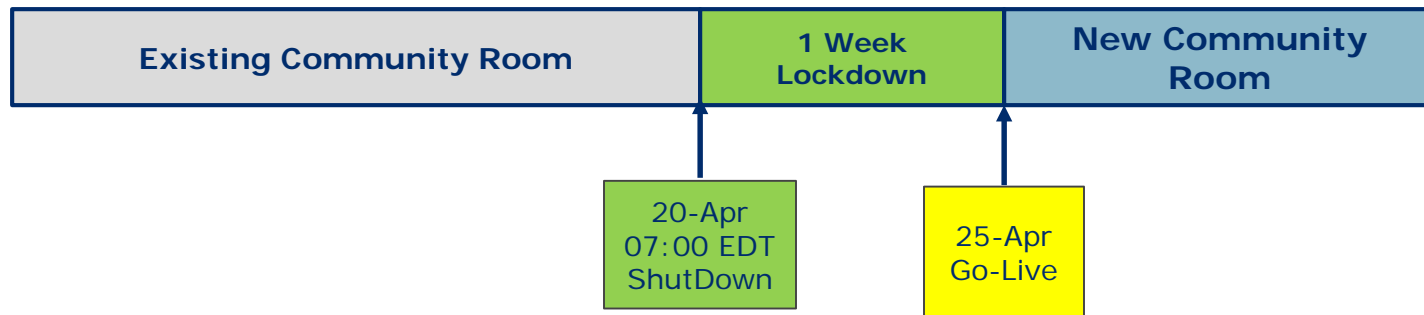
**Submitted by the German GDSN community to provide a solution to the following:**

- Milk Substitutes & Related Products is a growing category and retailers want to distinguish these products in a clear way, which currently is not possible since the existing bricks are combined.
- Many of these products have specific regulations (in Europe and possibly other countries as well) and certain distinctions need to be defined. If the bricks remain together with non-animal products, GDSN validation rules and retail validations cannot be applied. Additionally some attributes are only valid for one category, e.g. origin of cheeses or milk treatments.
